

## Provider Access Policy Statement

### INTRODUCTION

This policy statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

### PUPIL ENTITLEMENT

All pupils in Years 8-11 are entitled:

- to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events;
- to understand how to make applications for the full range of academic and technical courses and apprenticeships.

***For pupils of compulsory school age these encounters are mandatory and there will be a minimum of two encounters for pupils during the first key phase (Years 8-9) and two encounters for pupils during the second phase (Years 10-11).***

These provider encounters will be scheduled during the main school house. The provider will be given a reasonable amount of time to, as a minimum:

- share information about both the provider and approved technical education qualification and apprenticeships that the provider offers
- explain what career route those options could lead to
- provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and pupils from the provider)
- answer questions from pupils

## **PREMISES AND FACILITIES**

The school will make the Atrium (main hall), classrooms or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. The school will also make available AV and other specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the Careers Leader or a member of their team.
